First stop was the Human Services and Corrections Committee. Cheryl Monk, a SAIL member, and Brittany Graves did a fantastic job! This committee also got all of the written testimony about the importance of this bill. Then it was off to the Senate Ways and Means Committee where there was a hearing. It was passed out on the same day. The next stop was the Senate Rules Committee, also known as the graveyard. For the next week it was a constant run to the finish line. Notes to Rules Committee Members asking them to pull the bill, sitting in the Rules Meetings and then doing everything possible to get someone to bring it to the floor for a vote. Thank you Senator O'Ban! Now we are just waiting to hear when the bill will be signed by the Governor!
